To fill the vacancies left by these gentlemen Dr. Hanson, Dr. Cruickshank and Mr. Vauthier became chairmen of the Town Planning, Horticultural and Movie Club Committees The Baie D'Urfe Citizen's Association was formed in April 1947 for the purpose of developing and maintaining the interest of each citizen in the affairs of the community. It would appear that, to date, the association has served this purpose with a real measure of success. A high level of participating has been enjoyed and it is a general feeling that the community is being developed on the basis of group initiative to a degree which probably could not have been achieved without a citizen's association. On behalf of the association I would like to congratulate and extend a vote of thanks to the retiring executive. They were largely responsible for the organization and developing of what has proven to be a most valuable asset to the community. Your new executive is most anxious to be of service and to facilitate the further growth of the association to the point where every citizen is actively participating in a common objective, that of making Baie D'Urfe a good community in which to live. Public opinion is only of value when it is known. Our regular monthly meetings provide an excellent opportunity for discussion and group decision. The Executive will appreciate your regular attendance and is most anxious to have your opinions.

The Annual Meeting of the Baie D'Urfe Citizen's Association was held on Friday, January 14th. at 8 p.m. in the Town Hall. Chairman Phil Holliday was in the chair and a record number of members were present. The main items of business were the reading of the annual reports and the election of officers for the new year. With regard to the election of officers, Mr. Smythe, Chairman of the Nomination Committee, read the names of those nominated correctly by members in good standing. There being no further nominations they were duly declared elected. Their names will be seen on the front page of this issue. The two annual reports follow:

Without a doubt this past year the association has assumed a position of greater importance, improved the life and sociability of the community, and has always enjoyed the fullest co-operation and good will of the town council.

All members of the 1947 Executive were returned to office by acclamation with the exception of the secretary who tendered his resignation, and to fill this vacancy your present secretary was elected. At a special meeting preceding the general meeting in February, Mrs. Vauthier was elected assistant secretary to serve on the Executive.

During the course of the year Mr. Pennefather, Vice-Chairman, Mrs. Nagley, Editor of News and Views, and Mrs. Vauthier, Assistant Secretary, resigned from the Executive Committee. These offices were filled respectively by Dr. Cruickshank, Mrs. Gray, and Miss Jessie Martin.

Four amendments to the constitution were made, the most significant stating: "Save for the Editor of News and Views no person shall hold the same executive office for more than two years and no person shall be a member of the Executive Committee for more than three consecutive years.

Furthermore, the Educational and Cultural Committee name was changed and instead was called the Movie Club Committee, under the chairmanship of Mr. Peter Smith.

Unfortunately due to unforseen circumstances Mr. Pennefather, Mr. De Witt, and Mr. Smith resigned as chairmen of their committees. To fill the vacancies left by these gentlemen Dr. Hanson, Dr. Cruickshank and Mr. Vauthier became chairmen of the Town Planning, Horticultural and Movie Club Committees respectively.

Total membership in the Association for 1948 was 84 against 80 for the previous year and although a substantial number of new families have taken up residence in the town this has been offset to a certain extent by the resignation of a number of non-residents, also a few citizens who did not renew their membership, change over from single to family membership, and the fact that several of the new families who intend joining only took up residence the latter part of the year.

Activities of the Association included a sleigh drive, birthday party, Home Cooking Sale, Auction Sale, Hobo Hop, Baie D'Urfe Day, Horticultural Show, corn roast and the Childrens Christmas Party. The Home Cooking Sale enabled the Hospitality Committee to obtain necessary cutlery and chinaware to further the activities of the Association, and the Auction Sale benefitted the General Fund. Out of this General Fund an appreciable amount of money was given to the Recreation Committee to improve swimming facilities with the result that a boom and raft was constructed and part of the material required for a floating wharf procured. Mr. Binz kindly donated a trophy to the Association to be awarded to the winner of the Horticultural Show each summer and Mr. Wilson was kind enough to donate tea and loan the Association equipment in order to aid facilities on Baie D'Urfe Day. Letters of gratitude were also sent to the many merchants who made donations to the Horticultural Show.

One of the most important achievements of the Association was noted when the lights at the C.P.R. Station appeared after several months of negotiation.

The Movie Club improved their program with a better variety of pictures over the previous year and the Childrens Christmas Party was handled with greater success both financially and otherwise.

The Town Planning Committee was successful in having a number of clauses added to the Towns Building by-laws and in addition have made substantial progress towards the general planning of the community.

News & Views, published each month, not only was self-supporting but also showed a small profit. This can be attributed to the amount of advertising sold in 1948 which exceeded that of 1947 by 86%, an indication of the importance of this new local advertising media.

School Affairs Committee kept the citizens informed of the many developments which took place this year, the most important of which was the formation of a Central School Board. This change was brought about by McGill refusing to carry on the expense of operating the school under the former agreement. This resulted in increased taxation.

Considerable correspondence was carried out between Mr. Long and the Department of Veterans Affairs over the towns acceptance of Lake View Road. These negotiations were followed up by the Association to a point where it now appears as though settlement will be made fairly soon.

After considerable work a service scroll was drawn up and this has now been presented to the Council for whatever action they see fit to take.

On behalf of the Lachine General Hospital's campaign to raise funds for their new addition the Association undertook to canvas citizens in this town and as a result obtained a commendable sum of \$1,150.00.

Many discussions took place regarding the question of the towns drainage problems and as a trial the Town Council was requested to seriously consider the possibility of putting into force Professor Heimpel's scheme for the drainage of College Green.

Incidental meetings were supplemented by the following programs; movies, refreshments, school affairs, quiz, and address by Professor Heimpel on weed control and drainage, Fireproof paint by the Flamecheck Company, Application of Science to Gardening by the Canadian Industries Limited, Fire Prevention by Chief LePine, Puppet Show by Miss Joyce Hartnell and cast, and a skit by Mrs. Gray and Miss Kruse.

On October 16th a demonstration was held at the Town Hall with a piece of fire fighting equipment and in addition to this the Canadian Industries Ltd. carried out experiments on the killing of water weeds.

In closing this report the present executive recommends that the 1949 incoming executive retain Dr. Hanson as Chairman on the Town Planning Committee, that the subject of noxious weed killing be taken up with the council during the early part of the spring, and arrangements made for expanding the Hospitality Committees facilities at the Town Hall.
