

The objectives of the Baie d'Urfé Citizens' Association were listed in the constitution as follows:

- A. To enlist the interest of the residents of Baie d'Urfé in all matters affecting the community and to foster and promote among them a stronger spirit of citizenship.
- B. To further the economic, social, recreational, cultural, and other interests of the Town.
- C. To provide a means for the dissemination of information on all matters affecting the interests of the residents of the Town.
- p. To provide an organization through which the residents of the Town may communicate collectively with the Town Council and other authorities.
- E. To co-operate with the Town Council in promoting the general interests and welfare of the community.
- F. To co-operate with other organizations engaged in or supporting endeavours similar to the objectives of the Association.
- G. To invite all candidates for municipal office to address an open meeting of the Association.

Since its organization in 1947 the Association has been very active. It has enjoyed the valued support of the great majority of the citizens of the Town, and can boast of a long list of successful achievements.

The executive committee for the year 1949 has endeavored to maintain this high level of interest and activity and has endeavored to carry out the objectives of the Association as set down in the constitution; we hope to your satisfaction.

The fiscal year of the Association ends December 31st, and the annual meeting will be held on January 13th, 1950. As laid down in the constitution a general election of officers will be held at this meeting. One month prior to the annual meeting the executive committee must appoint a committee to receive nominations in writing signed by two members in good standing. The chairman and members of the nomination committee will be announced at the December Meeting.

Your chairman has appreciated the support and co-operation of all members of the Association during his term of office. I would like to take this opportunity of thanking, in particular, the members of the executive and chairmen of standing committees whose constant support have made my year in office most pleasant.

In retiring from office at the end of this year I would like to emphasize the importance of maintaining a high level of participation by spreading the responsibility of leadership widely within the Association. The regular introduction of "New Blood" into the executive positions will assist in maintaining the high level of interest which the Association has enjoyed. I would like to express my appreciation for the opportunity to serve the community during the current year.

The programme chairman announced that Dr. Leo Walker will address the next meeting on "First Aid". The Town Planning Committee then took over the meeting after which refreshments were served.

TOWN PLANNING: Following the business of the last monthly meeting, Dr. Hanson, acting as chairman of the Town Planning Committee in the absence of Mr. Dawson, took over the meeting. First a film was shown depicting the contrasts between life in a crowded industrial area, with its soot, mud, noise, overcrowding and insanitary housing conditions, and life in a rural community -- a garden city -with the houses amongst woodlands and fields and rural pathways for youth on bicycles. The film acted as an introduction to a few words spoken by Mrs. Case to inform the citizens that her project for a "safe-way" was still under consideration. Mr. Laird told of the Town Council's proposal to obtain an accurate aerial map and survey of the Town. Mr. P. Smith spoke on the proposal to bring before the taxpayers for their consideration a new building By-Law which would replace the small red book. stated that this By-Law must be approved by a referendum of the taxpayers, therefore it was urged by the meeting that all taxpayers be provided with a copy of the new By-Law, and time given for its proper study before the referendum is taken. Dr. Hanson stressed the fact that the Town Planning Committee were amateurs and could only go so far, and that expert advice was now needed. It was mentioned that the Town Council would probably invite an expert to act as consultant in this matter of Town Planning.

It is everyone's business and duty to take an interest in Town Planning and come forward with their suggestions.

SCHOOL AFFAIRS: The Central School Board met on Thursday, November 17th at 9.00 p.m. Four persons attended from Baie d'Urfé. It was disappointing to hear that the agreement with McGill had not been signed, but the chairman Mr. R. Angus stated that new proposals had been made which might change the situation to the advantage of our board. It was expected that this matter will be settled shortly. It was reported that Ile Perrot was now officially admitted to our Central Board and authority was given to purchase a reconditioned Provincial Transport Bus at a cost of \$1,000.00, to be used at a later date to carry the children of Ile Cadieux and Ile Perrot. It was stated that an attempt would be made to educate the public with regard to the law of the Motors and Vehicles Act which states that it is unlawful to pass a school bus (or any

bus for that matter) in either direction if the bus is unloading passengers. A notice is to be painted on the back of our bus as a start. One item of interest to taxpayers mentioned at the meeting was that a considerable sum of money had been paid in as grants from the Department of Education made up as follows:
