Every householder is familiar with that experience which comes about this time of pear when spring cleaning is in the air - the experience of bringing to light again things which have been saved because they might "come in handy" but lost sight of temporarily under the debris of day-to-day living. Such might be considered the record of the activities and achievements of our Association as recounted in the past issues of News and Views carefully hoarded by its editors. It seems to your executive, that it would be timely to blow the dust off this file, as it were, and set out in brief form an account of the subjects with which the Association has concerned itself both to enlighten the newer members and to refresh the memories of those who may have forgotten what has been done. It is proposed to present this material in forthcoming issues of the paper that those who are still running may read.

### THE RECORI

The regular monthly meeting was held at the Town Hall on March 9th, 1951 with John Windebank presiding. Three students from the Sociology Class at Macdonald College who are taking the Baie d'Urfe Citizens Association as their special study project were welcomed. The minutes of the last meeting were read and adopted. New residents introduced were Wr. J.F. McKenzie of Lakeshore Rd., Mr. D.G. Edwards of Lakeview Rd., and Dr. and Mrs. Swan, of Morgan Road. Mr. Waverley reported a present paid-up membership of 75. His eleven member committee has zoned the Town with a committee member in charge of each section, as follows: College Green - Mr. Buch; Lakeshore Rd. - Mrs. Christian, Mr. Laird, Mr. Greenfield, Mr. McGuire, Mr. Bjorn, Sunny Acres - Mr. Nikclaizuk; Morgan Rd. - Mr. Greenfield, Mr. Waverley; Lakeview Rd. - Mr. Perkes, Mr. Cochrane. Mr. Ritchie reported that his committee had decided to work on the playgroum project without waiting for the Town Council to act on the request for a grant of money. (A complete report of the committee's activities is detailed elsewhere in this paper). Reporting on School Affairs, Mr. Fry noted that at the last meeting of the Central School Ecard, salary increases to the present scale of the Montreal School Board had been voted. It is expected that the plans for the new school will be completed by the end of March, and when they have been approved by the Provincial Department, tenders will be called for. It is hoped that building will be started this spring. Correspondence regarding postal services was read including a letter from Postmaster-General Rinfret in reply to an inquiry by Mr. Duncan regarding carrier delivery service. Mr. Rinfret informs us that in order to establish independent carrier service, an area's postal revenue must exceed \$50,000 per annum and the number of points of call to be served must exceed \$50,000. Therefore Baie d'Urfe cannot be considered eligible for this service. The Corresponding Secretary has sent out other letters in accordance with requests mad

It was announced that a referendum on the subject of minimum area for new building lots in zone P was planned by the Council but has been postponed. The balance from the Christmas party Fund of \$28.45 was voted to the Recreation Committee for use in its Current projects. Mr. Vidler's suggestion that Committee Chairman, unable to be present at a meeting, hold themselves responsible for putting committee reports in the hands of his committee for presentation, was approved. The campaigns of the Red Cross Society and the Lachtme General Hospital Women's Auxiliary were announced for the immediate future. Following the conclusion of the business, Messrs. Windebank, Smythe, Nagley and Cruickshank presented a discussion on the origins, objectives and accomplishments of the Paie d'Urfe Citizens Association. Hostesses for the evening were Mrs. Grimm, krs. Pinkey and Miss Barbara Nagley.

A panel discussion was held on the "present status and future objectives" of the Citizens Association at its March meeting. Heading up the panel was John Wirdebank, present chairman. After a few introductory remarks, Mr. Windebank introduced the other members of the panel, all of whom are past chairmen; Harvey Cruickshank, Sid Nagley and news Smythe.

Mr. Smythe, one of the "founding fathers", described how the Association began out of a growth of community spirit and interest in town affairs. Mr. Nagley reviewed the past activities and functions which the Association has sponsored. Dr. Cruickshark misussed the objectives of the Association past and present. The panel then covered association problems in general. Following this the audience was divided into three groups under the leadership of Fred Ritchie, Lionel Evans and Mary Coulter. These groups omaicered the major and minor problems of the community and Association with particular reference to the future. The discussion leaders reported back to the meeting, reconvened as whole. It is important to note here, for the benefit of those not present, that the following items reported were not necessarily the views of the majority of any one group mr, of course, of the meeting as a whole.

Mr. Ritchie's group expressed some concern at the relatively small percentage of the town residents who were paid up members of the Association, and hoped that there would be action on this. The suggestion was made that a steering committee deal with mimor and local complaints and save time at meetings. This group felt that the Association should cultivate an attitude of co-operation with the Town Council as opposed to me of distation. Mrs. Coulter's group discussed the present system of electing the Town founcil. It was felt by some members of this group that there was danger in this system of the councillors becoming the pressure group of the Citizens Association and not repose the Association. It was suggested that consideration be given to the formation of a fire brigade. Mr. Evans said that the members of his group had discussed the following points: the considerable delay in the posting of new road signs; recreation, the opinion was expressed that the recreation report may stimulate interest in this problem; attendance at meetings, it was felt that the poor ventilation of the hall was responsible for some lack of attendance and that this was not only due to the discomfort but also because of health in the case of members having sinus trouble, etc.

The comment regarding election of the Council brought forth spirited discussion.

A suggestion was made that meetings be held less frequently than monthly and this also brought forth divergent views. It was explained that the matter of paid-up membership was less serious than would appear, since it was a common occurrence for a large percentage of the dues to be unpaid at this time of the year.

### HORTICULTURAL SOCIETY

The Horticultural Society is making plans to supply peat moss or black muck, fertilizers, insecticides and some seeds to its members at wholesale prices through quantity buying. A detailed announcement of supplies available and prices will be mailed to members in a couple of weeks. If there is sufficient demand, peat moss can be supplied at approximately \$2.50 a large bale, delivered Stc. Annes. This will be the fine granulated horticultural grade. About 150 beles would have to be ordered to obtain this price and the plan cannot be proceeded with unless there is assurance that we can dispose of this quantity. As an alternative, arrangements may be made to purchase lack muck at approximately \$3.00 a cubic yard.

Members who are interested in obtaining supplies, particularly the peat moss, should wise Ernie DeWitt, phone 2331 or Ewing Tait, phone 876, at once. Information on prepared materials and approximate quantities is required now.

The contract with Scott for snow-clearance has been cancelled. Negotiations with Commelly will be continued by the Council.

The Building Inspector will be asked to investigate Mr. Clarson's statement that his lot is encroached upon at one corner by the Lakeview Read.

A complaint that the Goodwell barn is a fire hazard is resulting in the renewal of the Council's demand that the condemned building be pulled down. Destruction may be undertaken by the Council with the bill for costs being presented to the owner.

The Council's demand that the old excavation on Eorgan Road, be filled is also being renewed and will be pressed to a conclusion.

The work on preparation of a town budget is continuing but no figures have been resented yet.

A request was heard from the Citizens Association that when far-reaching developments (such as the proposed referendum on building-lot sizes) are under way, the Council make some effort to keep the executive of the Association informed of significant moves.
